**\$25.00 for a 10' x 10' space**

*Curbside – on High Street, between Broad and Main*

*Note: Registered exhibitors that do not attend  
will be charged a \$50.00 'No Show' fee.*

### Exhibitor Location

*Location is at the discretion of the committee.  
Exhibitors must bring and set up their own stabilized  
tent, which shall be no larger than 10' x 10',  
able to be erected on the street*  
**No exhibitors allowed without tent  
(excepting Plein-Air artists).**

### New Jersey Sales Tax

*Exhibitors are responsible for collecting  
NJ sales tax (7%), regardless of their home state.  
To participate, exhibitors MUST provide tax I.D. number.*
